- A formal written response by the DRB will be sent to the Applicant and Lone Star Association upon each review cycle. Lone Star Association will work with the applicant to ensure proper implementation of all DRB Comments.
  - Applicant will be notified within 15 days by the DRB of any submission deficiencies. Such plans shall not be considered to have been submitted until such deficiencies have been corrected.
  - Please remit payment to the DRB at time of submittal. See attached fee schedule for reference.
  - Due to project proximity to Alliance Airport a formal submittal to the FAA may be required.
